## **CIRCULAR**

Subject: Monitoring of Anti-Ragging measures in Nursing institutions as per UGC guidelines-regarding.

Sir/ Madam,

As per the UGC 15<sup>th</sup> Inter Council Committee Meeting guidelines, all Universities, State Registration Nursing Council & all the Nursing School/College should follow the guidelines as below:

1. All Universities, all State Registration Nursing Council & all the Nursing School/College are to ensure adoption of the revised procedure for filing online anti-ragging undertaking which are available at [www.antigagging.in](http://www.antigagging.in) & [www.amanmovement.org](http://www.amanmovement.org)
2. All Universities, all State Registration Nursing Council & all the Nursing School/College to also download and **display 04 anti-ragging posters** on their **Notice Boards** and **Website** which are available at Indian Nursing Council website: [www.indiannursingcouncil.org](http://www.indiannursingcouncil.org) and also at [www.antigagging.in](http://www.antigagging.in).
3. The Council may advice to all nursing institution, if the institutions are collecting any penalty on ragging incidents occurring in their institution, they should utilize the same for creating awareness on anti-ragging activities within the institution.
4. Nursing institution to submit the action taken report on anti-ragging website henceforth. Institutions are to update the status of the complaints of ragging which arise in their institutions and close immediately as & when resolved.
5. Electronic Notice Board to have rolling posters and videos on anti-ragging at their websites/ colleges.

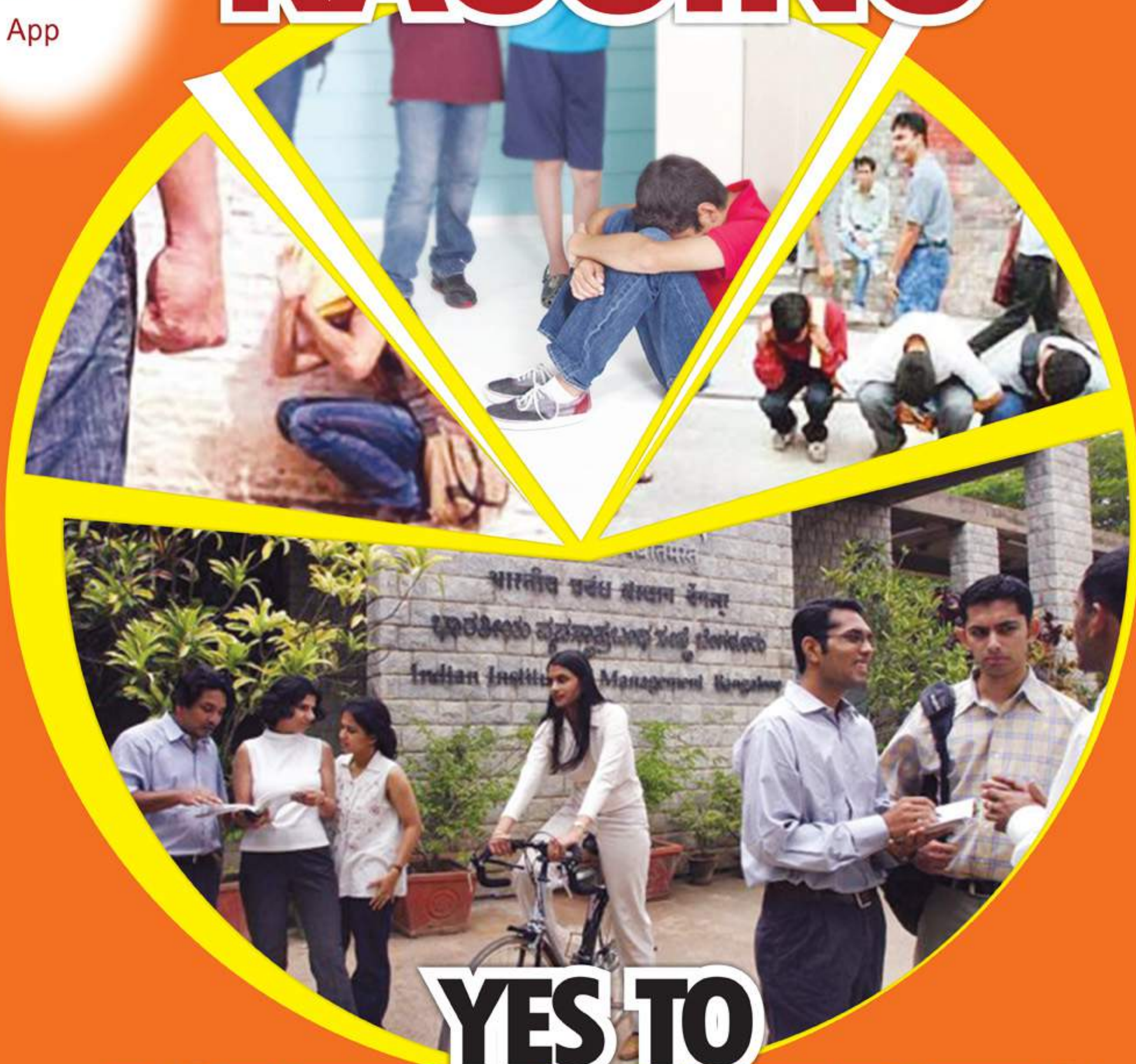

## What is Ragging?

**Any Act Resulting in:**

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

### A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

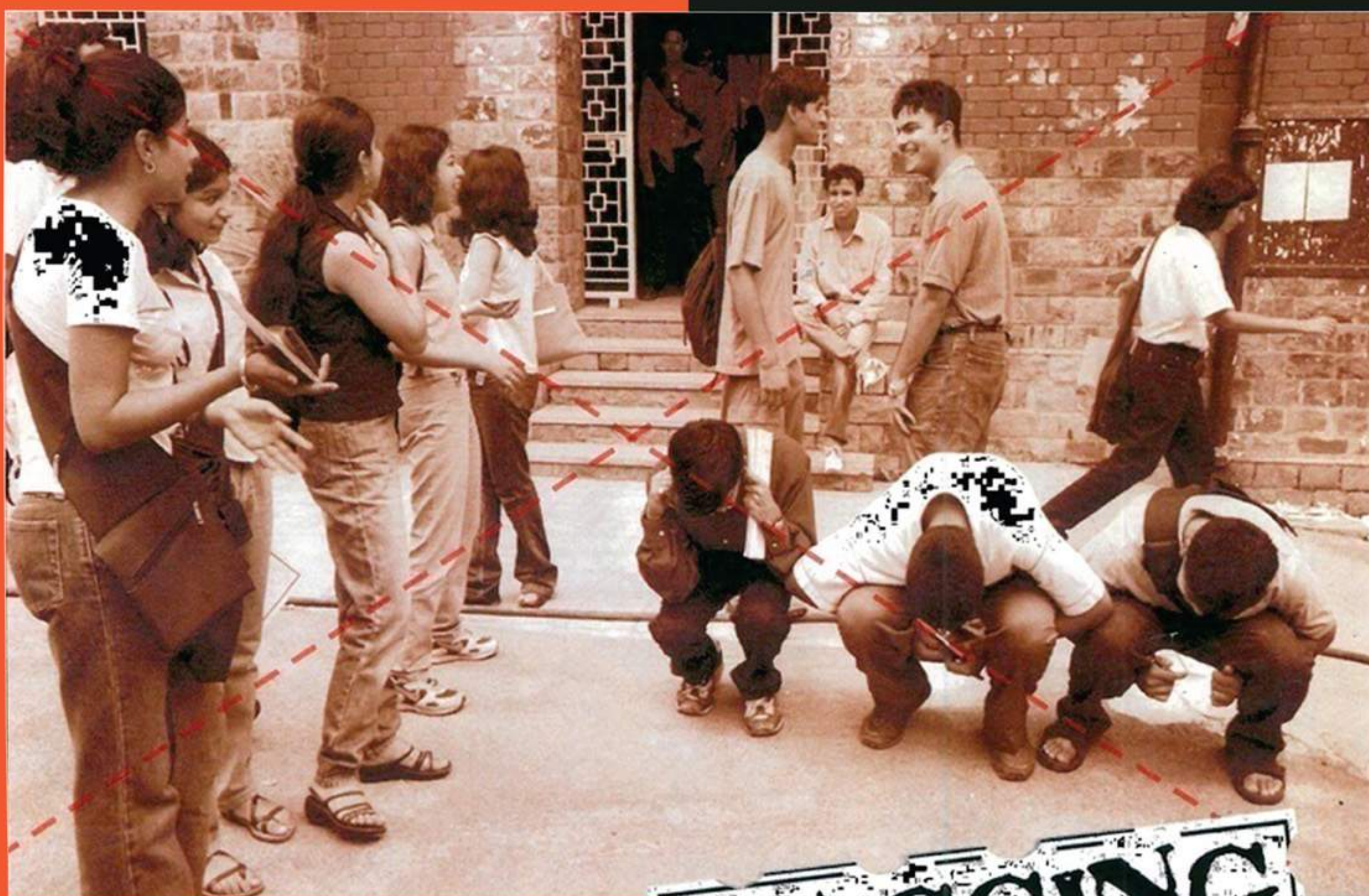
